2018-9 School Subsidy Agreement

The cost of educating a student at Saint James School is over \$7,000. This cost continues to rise but Saint James School tries to keep costs low for Catholic families. The cost for a non-parishioner to attend Saint James School is \$5,800 and the rate for a parishioner is \$4,290.00. Financial aid is also available for students that are most needy. We ask that you prayerfully request what you need so that we are able to meet the needs of all our families.

Good Shepherd Parish provides money to Saint James School to lower that cost making a Catholic education accessible for all students. Good Shepherd Parish is most generous contributing over \$260,000 per year to Saint James School. We are grateful to our Parish and hope that many of you will be able to return the favor and contribute your time, talent and treasure to Good Shepherd Parish and our school community.

If you want to qualify for the reduced tuition, certain requirements must be met. Good Shepherd Parish provides this subsidy for its parishioners. Your stewardship of time, talent and treasure and participation in the school and the parish show us that you are an active parishioner and qualify for this parishioner rate. Stewardship can be shown in these ways.

1. Being a registered parishioner at Good Shepherd Parish.
2. Worshipping regularly with the Good Shepherd Parish community.
3. Supporting Good Shepherd Parish with recordable income through envelope giving or through the WeShare program.
4. Supporting the Bishop's Appeal and school fundraising events.
5. Use of your time and talent in the ministries and organizations of the Parish and/or Saint James School. Some examples of how you can contribute your time, talent or treasure are listed below.
6. Participate in an adult education program at Good Shepherd Parish to enhance your spiritual life.
7. Making regular monthly payments through FACTSmgmt.com.

If you fulfill the above requirements, the gift of a parishioner rate is available to you. If you do not fulfill these requirements, you risk losing this gift.

We ask that you prayerfully discern what your ability to pay is and if you are financially able to make an additional contribution, please consider to do this as you will be helping out another family.

If you attend a different parish in the area, often they will help subsidize your child and you will also be eligible for the parishioner rate. Please speak with your pastor.
